Log in to website, go to tab for Member Central, drop down and scroll to Monthly Statements and set up either ACH or Credit Card payment

Applicant agrees to pay all reasonable attorney fees to collect any outstanding debts in the event this account is turned over for collection.

Applicant agrees to hold the Club and its employees/contractors harmless in the event of any on premise accidents.

Applicant must meet with Membership Committee & General Manager prior to granting of Member status.

2023 POOL/RACQUETS NON-EQUITY SUMMER MEMBERSHIP

For the 2023 summer season, The Racquets Club of Short Hills is offering a new class of non-equity membership on a one-time-only trial basis. This is a seasonal Membership, open to all, pending recommendation of a current member and approval by our Membership Committee.

This membership will run from May 26 through September 8, 2023.

Each Summer membership will cost \$ 3,000 per family. Membership includes full usage of the Club for your immediate family during operating hours for the membership period.

Full payment is due, payable by check to be submitted with this completed application before applicant may utilize any facilities. Under no circumstance will club usage or play be permitted without payment in full. Monthly statements for all purchases will be sent via email approximately the first week of each month and are due upon receipt. A personal credit card <u>must</u> be kept on file but will not be charged unless payment is more than 60 days late.

Summer members are not equity members of the Club and as such do not have a say in club affairs. Summer members are welcome to join tennis/pickleball socials, tennis/pickleball clinics, swim team (if applicable), and social events which are hosted on a regular schedule throughout the season. (Covid-19 restrictions may apply)

Summer members are permitted to play with other seasonal members as well as regular Club Members and are encouraged to join or form RCSH teams in conjunction with the Club Pro; seasonal members are permitted guest privileges with payment of appropriate guest fees.

Summer members may take lessons from the Club's Racquets Pro but may not bring outside Professionals on premise for teaching or other reasons. Summer members may reserve courts and are encouraged to do so.

Summer members do not have access to our commuter parking lot. There is a parking at the pool and tennis courts when using the club facilities with the exception of parking in the main commuter lot after 5:30 pm.

Summer members are subject to a food minimum (\$150 per month plus \$40 per month service fee) and they may utilize the Poolside Cafe or Hobart Grill. The food minimum is exclusive of all beverages, alcoholic or non-alcoholic.

This Summer membership is a one time trial membership for one family and may not be repeated in the future.
